
GREEN OPERATORS "GO" Program Rebate Program Application Instructions



The Green Operators (GO) Program provides rebates to retrofit older vehicles with diesel emission reduction equipment and recognizes partners for setting and achieving goals for reducing air pollution and greenhouse gases associated with the transport of goods.

Eligible Applicants

- Carriers must provide drayage truck services to the Virginia Port Authority's Hampton Roads facilities. Proof of Port service can be established via a Port of Virginia ID Card. Please send a copy (front and back) as an attachment to your application.

General Requirements for Applications

- Incomplete applications will be returned.
- Complete applications will be reviewed on a first-come first-served rolling basis and will include a copy (front and back) of a valid VA Port Authority ID card.
- Applicants certify by signing the application that the truck in the application is being used to transport cargo to and from the Port of Virginia.
- If you need space for additional information, attach additional sheets of paper. Write the owner's name on each attached sheet and attach to the application.
- Provide an itemized cost of equipment, materials, etc. with your application. Please include any product literature, specifications, brochures, etc. that would be helpful in evaluating your application.
- Equipment must be on the Verified Technologies list of the U.S. Environmental Protection Agency (EPA): <http://www.epa.gov/cleandiesel/verification/verif-list.htm> or the California Air Resources Board (CARB) verified technologies list: <http://www.arb.ca.gov/diesel/verdev/vt/cvt.htm>.
- Equipment must be purchased and installed no earlier than the effective date of a fully executed Rebate Agreement and no later than July 31, 2013.

Application Review & Approval Schedule

1. Applicant completes rebate application and submits to MARAMA.
2. MARAMA confirms receipt of application within 10 business days and notifies in writing of acceptance or denial of application within 21 business days of receipt of a complete submittal.
3. MARAMA sends two copies of the Rebate Agreement to be signed by approved applicant.
4. Applicant signs both copies of the Rebate Agreement and returns both copies to MARAMA.
5. MARAMA signs and returns a copy of the fully executed Rebate Agreement to applicant.
